- Voters should not have to re-verify their eligibility at each meeting; requiring a photo ID to vote excludes many community members from fully participating in the organization. Additionally, this current bylaw goes against state and city requirements.

- Again, as stated in the [City of Minneapolis Community Participation Program Guidelines](#): “Consistent with the State Non-profit Law, all residents of the neighborhoods are considered members with voting rights if **(1) they are on a preexisting membership list**, or (2) at a meeting of the neighborhood organization can produce Minnesota driver's license, Minnesota identification card, or some form of residency verification that indicates the individual resides within the geographic boundaries of the neighborhood organization. **Neighborhood organizations must accept non-photo ID methods for establishing residency**. Notice for an annual meeting must include notification of any requirements for residency verification.”
