# **Introductions & Meeting Overview**

- Welcome at 6:34 pm by Nick Hutchinson.
- A round of introductions is done.
- The Standard of Conduct and Conflict of Interest Policies are reviewed.
- The agenda is reviewed.
- The minutes from October are reviewed.
  - Motion to approve the minutes from the October 2022 meeting is made, seconded, and approved.

## Former Kmart & New Nicollet Ave Redevelopment Project - Adrienne Bockheim & Rebecca Parrell

- The former Kmart site came back into City control in 2020, and since then they have been developing a process for how to begin engaging community on the future of the site and reconnecting Nicollet Ave at Lake St.
- There will be 3 Phases of Engagement across a number of years
  - Launch and Listen Sept 2022 Jan 2023: Creating a Characteristics of Success Document and an Engagement Summary after hearing from community about various quality of life topics like housing, transportation, small business opportunity, public spaces, and more.
  - Phase 2 (March--December 2023): Adoption of a New Nicollet Layout Plan and Public Space Plan
  - Phase 3 (2024 and beyond): Development
- The engagement focus area is overviewed and some examples of the types of engagement activities are shared including a public open house, door knocking to both residents and businesses, and targeted focus groups with historically under-engaged community groups.
- <u>The project expectations document</u> outlines the things the City already knows about the project based on established City policies, as well as the items are still to be determined based on community input, anti-displacement studies, and other factors; this is the most effective way to get a good understanding of what is happening with this site and where the opportunities to engage and influence the outcomes will be throughout the engagement process.
- Discussion Questions:
  - Build for who is there: what specific ideas do you have for ways that this project can benefit those who live and work here now?
    - Question about who the stakeholders are. A: business owners, residents, property owners within about a half mile around the site
    - Want to take a moment to dream and see this project through the eyes of a 7 year old --What does a kid see and want? Maybe a public plaza that is theirs; a place for kids to exist and be welcome inside
    - Has heard a lot about the fact that Kmart closing has created a gap in his neighbors' daily needs

- GREENWAY! This is the time NOW to figure out how this connects to future transit in the greenway corridor; if not, how can we create active green space in the greenway trench to be UTILIZED in the intervening years?
- City is hitting the nail on the head in terms of the project expectations doc
- Agrees with previous comment on creating a park-like atmosphere
- Underground parking will be important to talk about if we can create park space for the street level
- ADA accessibility access at the Greenway is important
- Interested in working with first-time homebuyer organizations to check into feasibility for wealth creation; thinks mixed income level projects is the way to go to make the project more feasible
- Condominium type housing would create another entry point for homeownership
- Health and safety elements are very important; would be interested in on-location security 24/7 and a safety center in partnership with MPD
- Include a space for community meetings
- Concern about the fact that affordable housing doesn't contribute towards building generational wealth; likes the idea of condominiums and would like to see green spaces within a certain secured building for residents to utilize to grow food and; an investment that is theirs to pass down to someone else in their family; there are work to own models that could be creative and new for Minneapolis
- Need access to fresh groceries that are affordable
- Biggest challenge as a small business is the inaccessibility of owning their own spaces; has been renting his space for 17 years and hopes that this project will create spaces for business owners to own their spaces rather than just lease

## • Transportation: How do you envision a New Nicollet Ave to look, feel, and function?

- Connecting to the Greenway in this area has certainly been a goal of the City for many years, and the City has been meeting monthly with the County for many months to prepare for how that will happen; ADA accessibility in Whittier to get to the Greenway has been a challenge for a while now that the City wants to remedy that.
- Q: Will there be a possibility for things to be added to the Nicollet Ave bridge that goes over the Greenway? A: Project will span the curb line at Lake Street and will go all the way north to the curb line of Cecil Newman Way; the design and functionality will be focused on in Phase 2 of the engagement this year.
- Minneapolis is going through a rough patch in terms of community safety; this project can help us get our footing back
- Would like to see places for people to gather, and they hope to put young people first in that; create places for **people and family**, places for them to walk and feel safe
- Bus rapid transit on Nicollet and bus priority lanes? A: Yes, they are working with Metro Transit; the Lake Street B Line Bus Rapid Transit project does have bus priority lanes getting constructed in the next couple years before Nicollet is reopened
- How it should look, feel, and function? The project will have failed if it looks, feels, and functions like other surrounding roads; if it looks very different and people feel safe walking around, it will be a success.

- Best example is Milwaukee Ave that has no cars at all, but also the south part of Bryant Ave was just recently redone is a greatly improved area.
- An entrance to the Greenway wants to be sure the connection to the Greenway will be something we are PROUD of; include public art, landscaping, and intentionality.
- Places for people to be picked up by Metro Mobility or picked up in a car loading zones, other designated places for those who cannot walk or bike
- Would like to see that biking stations are incorporated Nice Ride station, and a secure area to unlock and park bikes and scooters.
- Community Health and Safety: What elements and experiences provide you with a sense of safety? What does a healthy community mean to you?
  - People need access to food, goods, and transportation to jobs that pay the bills
  - People need access to permanent housing and healthcare that aren't going to go away
  - A community center where people can come in to warm up in the cold
  - Access to jobs
  - Center the small business opportunity piece from the get-go as an important element of hyperlocal job creation; don't include the small business space as an afterthought -design for it specifically from the beginning
  - Employment and job training programs on the site!
  - #1 thing that makes them feel unsafe fast, loud, polluting cars; safe and separated bike lane, safe sidewalks are important; doesn't want Nicollet to be a highway for people just to get through to downtown and back; it should be built for the uses of people who live here not those who just travel through.
  - Absolutely agrees verbatim of what the last person said; air quality is also threatened by cars
  - Concern about what is in the soil under the Kmart if there are going to be parks and community gardens. A: The City will be doing a full cleanup that MPCA and other environmental oversight bodies will require; they've had initial soil samples and review done, and it is actually not in terrible shape.
  - More kids in 3 of our census tracts than are in the Cedar-Riverside Towers; what is happening for kids before and afterschool? How can this site accommodate Pre-K options, afterschool programs?
  - This site is in a challenging location with high intensity streets surrounding it; how to make it safe for kids to get to and from?
  - TRAFFIC CALMING draw from the urban design toolkit of speed bumps, raised sidewalks, weaving the road - all those things should be put into play here to make it not just another street or intersection; can serve as a model for other infrastructure projects
  - Housing families are always looking for Section 8 housing with apartments that can accommodate many kids; hard for mothers who have multiple kids to be able to afford a down payment for an ownership option; include multiple options for affordable, familysized rental AND affordable ownership.
  - Many people used the Kmart site and now they do not have anything they can walk to
  - Dangerous sidewalks and pedestrian infrastructure & poor snow management from Horn Towers to this site needs to be addressed
  - GREEN SPACE is very important, but people need to be comfortable with their kids going out to enjoy the parks on their own, crossing busy and dangerous streets

- Minneapolis is cold 6 months out of the year, so we need to be sure we are considering how the public space is designed for winter enjoyment as well.
- Is the city open to a skyway as a part of the development? A: The comprehensive plan shows a map of where the skyways can go and it's downtown; would the City be open to doing something here? Not very likely given that policy guidance.
- **Q&A** 
  - How will the City be looking to recoup the major investments they've made in acquiring and developing the site? A: The City hasn't decided how the property will be sold off or reinvested or long-term leased, but there are fair market value laws that they will need to comply with if and when the time comes for that to be decided.
  - Would be interesting to see how we could position the types of housing and transportation that can get to good paying jobs - access to work.

## Ward 10 Councilmember Aisha Chughtai

- City budget 2023 Ward 10 office budget priorities
  - Ward 10 is home to an 80% renter community and a high population of transit users, youth, and families; priority was investing in traffic calming measures - additional 5-10 traffic calming neighborhood projects for Whittier - 1st time the City has ever allocated money for this use in the budget like that
  - Also worked to set aside money for legal defense for people going through eviction court anticipating about \$500,000 each year for the legal partners they work with (Mid-Minnesota Legal Aid, others)
  - Updates to fire suppression systems in the remaining 3 high rises that do not have them due to age of the building, which is a big deal
  - Worked on expanding our immigration support services
  - Something she supported but that did not pass was a municipal snow and shoveling program (\$200,000 pilot); going to keep working on this, has research coming back from the pilot that they will review and discuss this year
  - The year ahead priorities
    - Kmart and New Nicollet preferred concept design will be voted on towards the end of the year; her office will be supporting Whittier Alliance in holding the engagement work for this project
    - Rent stabilization workgroup came back with a set of recommendations after a year of work 30 different stakeholders including both renters, landlords, and property managers; now it moves through the City's policy approval process. The goal to get this back on the ballot for this November's election; lots of work coming on that this year
    - Unsheltered homelessness response they expect historic, unprecedented amount of money coming from the State this year for this issue, so they are gearing up for putting that into action
    - Started work with the State and district court on the consent decree coming out of the State of MN about MPD's racist practices; there is also the Federal Justice Department's investigation into MPD; it will cost a lot of money to implement but will be backed by court authority this time.
